**RECRUITMENT FOR: Building Services Worker (4556)**

**SALARY: \$21,188 - \$32,655 as of 8/2011 (Grade 5)**

**CLOSING DATE: Open and Continuous**

**POSITION DUTIES:** A Building Services Worker is the full performance level of work in the maintenance, housekeeping and general servicing of State buildings. Employees in this classification do not supervise. Employees receive general supervision from a supervisory position in the employee's area of assignment. Employees in this classification may be assigned to day, evening, night or rotating shifts which may include weekends and holidays. Employees may be subject to call-in on a 24-hour basis. The work may be performed in extremes of heat and cold. Employees may be exposed to noisy, dirty and uncomfortable conditions. The work may require the use of protective equipment such as gloves and masks when handling infectious material, masks and respirators when working around asbestos, goggles when operating machinery and power tools, back braces when moving furniture and safety shoes and gloves when performing maintenance duties. The work may require working in confined spaces and at various heights and moving heavy objects.

This particular position performs basic custodial duties in 11 buildings on the State Military Reservation, Havre de Grace, MD.

**MINIMUM QUALIFICATIONS:**

**Education:** None.

**Experience:** Six months of experience in building maintenance, cleaning and servicing.

**LICENSES, REGISTRATIONS AND CERTIFICATES:**

Employees in this classification may be assigned duties which require the operation of a motor vehicle. Employees assigned such duties will be required to possess a motor vehicle operator's license valid in the State of Maryland.

**SPECIAL REQUIREMENTS OF THE CLASSIFICATION:**

Employees in this classification may be subject to call-in 24 hours a day and may be required to provide the employer with a telephone number where they can be reached.

**SELECTION PROCESS:** Applicants who meet the minimum and selective qualifications will be evaluated on the materials submitted in relation to the above specific position requirements. The examination will evaluate the candidate's knowledge, skills, and abilities as they relate to the duties of this job classification. Therefore, it is essential that you provide complete and accurate information on your application.
