NATURE OF WORK: This is the full performance level of work of law enforcement work enforcing laws, rules and regulations governing the safety and protection of personnel and State and federal property at Martin State Airport, Warfield Air National Guard Base, Middle River, Maryland, 21220; Fifth Regiment Armory in Baltimore City, 20201; Camp Fretterd Military Reservation, Rue Saint Lo Drive, Reisterstown, Maryland 21136; or other Maryland Army National Guard Armories.

MINIMUM QUALIFICATIONS:

Education: Graduation from an accredited high school or possession of a high school equivalency certificate

Experience: Six months of experience as a military police officer

Note: Satisfactory completion of the Ground Combat Skills Course and the United States Air Force Security Police Academy can be substituted for the required experience.

LICENSES, REGISTRATIONS, AND CERTIFICATES:

Employees in this classification may be assigned duties that require the operation of a motor vehicle. Employees assigned such duties are required to possess a motor vehicle operator's license valid in the State of Maryland.

SPECIAL REQUIREMENTS OF THE CLASSIFICATION:

1. Employees in this classification are required to meet the following criteria:
 - a.) Employees are required to be active members of the Maryland National Guard.
 - b.) Employees must have successfully completed or have a confirmed date to attend the Grounds Combat Skills Course and the United States Air Force Security Police Academy or other military service equivalent course.
 - c.) Some candidates must meet current Air Force physical standards as required by Regulations AFI 48-123 and AFI 40-501 (Warfield). Others must successfully pass a State pre-employment medical examination (Camp Fretterd).

- d.) Employees may be required to obtain a secret security clearance as stated in the Personnel Security Program Management Regulation AFI 31-501.
2. Employees in this classification will be required to bear firearms and to demonstrate practical knowledge and proficiency in the safe use and care of firearms on an annual basis.
 3. Employees are subject to call-in on a 24-hour basis and must provide a telephone number where they can be reached.
 4. Employees in this classification are subject to substance abuse testing in accordance with Code of Maryland Regulations 17.04.09, Testing for Illegal Use of Drugs.
 5. Employees in this classification are subject to a criminal history background check.
 6. Employees in this classification working at Maryland Army National Guard Armories must satisfy the requirements for a Maryland Special Police Commission and firearm permit.

SELECTION PROCESS: Candidates who meet the minimum qualifications will be placed on the employment list in the Best Qualified category and remain eligible for selection for a minimum of one year provided that National Guard membership is current.

TO APPLY: Complete a Maryland State Form MS-100 (Application for State Employment) noting position title on the top of the form. Resumes will not be considered. Copies of documents attesting to qualifications must be attached to the application.
